Christopher Bridge Thomas Bridge Adam Bridge Elizabeth wife of John Howorth of Cranshaybooth and Margaret wife of Micheal Bates of Norland equally to be divided amongst them and my will and mind is that Christopher Bridge my said eldest sonne shall pay unto Susan [Josian] and Christopher Bridge his youngest children the summe of twelve shillings out of his exportonable part of goods to him by this my will and Testament given and bequeathed equally to be divided betwixt his said children Provided always and my will and mind further is That if soe it fortune that any of my said five Children shall dye and depart this life before the expiration of my natural life that then his part and porton of goods to him given by this my will shall goe unto his child or Children and Lastly I doe hereby make my sonne Adam Bridge Executor of this my Last will and Testament hopinge He will performe the same as my Trust is in him reposed In
